3. Sufficient Safety equipments like life buoy, life jacket, First Aid Kit etc. are to be kept with the boats. Experienced Boat Men / Crew Members will operate the boats.
4. The boat must in perfect operational condition.
5. Bank Account details have to be submitted along with the Quotation
6. When a boat is hired repairing charge is to be borne by the owner.
7. All risks including damage to the Boat and other persons/ property shall remain the liability of owner of the Boat Owner and the undersigned shall not be liable for any legal and /or financial liability except payment of the hire charges.
