TERMS AND CONDITIONS

1. The intending tenderer have to submit documentary evidence of registration in case of travel agent.
2. The mile metre must be in good working condition in case of light motor Vehicle.
3. Selected tenderer must be in a position to provide Vehicles as many as required.
4. The tenderer must have a contact number and must be able to provide vehicle within an hour on receipt of intimation over Telephone of requisition order.
5. The tenderer have to submit PAN and Income Tax clearance certificate.
6. The intending tenderer must submit Xerox copy of GST registration certificate.
7. Rate must be quoted in prescribe format, otherwise tender will treated as canceled.
8. The tenderer have to submit earnest money of Rs. 10,000.00 (Rupees Ten thousand) only in the form of all deposit/Bank draft in favour of Deputy Commissioner, Dar rang, Mangaldai.
9. The Rate quoted by the tenderer shall remain valid for period of one year from the date of execution of the agreement.
10. Fuel shall have to provide by the office and shall maintain a log sheet per KM. Basis accompanied by log-sheet duly certified by the officer using Vehicle. Daily allowances if any, for driver will have to be borne by the tenderer.
11. The intended vehicles are to be placed at the office of the undersigned or on the place directed on time. Period of utilization reading of mile metre will be from/after the arrival at the above place.
12. The Vehicles may have to place at any time on the day during 24 hours.
13. The tenderer is liable to clear all Tax/duty of the vehicle to be used for the purpose.
14. Income Tax will be deducted from the bill as per norms.
15. The undersigned reserves the right to cancel/reject the tender (s) without any prior intimation.
16. The driver of the Vehicle must as certain that the log-sheet is duly filled and signed by the officer using the Vehicle.
17. In case of KM. reading is found to be faulty on checking, a penalty of Rs. 500.00 shall be imposed and the Vehicle have to be replaced.
