2. The successful bidder is bound to supply standard and good quality/hygienic food items.
3. The bidders should be well experienced. Documents of Past experience should be enclosed with the quotation.
4. The successful bidder must arrange sufficient manpower for cooking and service to the polling personnel.
5. Neat and clean disposable utensils to serve food items must be arranged by the successful bidders.
6. The successful bidder will be liable for cleaning the refreshment area after completion of the works.
7. The rates should be inclusive of all taxes (including GST).
8. The bidders will have to deposit an amount of Rs. 20000/- (Rupees twenty thousand) only with the quotation in the form of Demand Draft/CD in favour of Deputy Commissioner, Darrang, Mangaldai as security deposit payable at Mangaldai.
9. No advance payment will be made.
10. Payment of bills will be made after election process is over subject to availability of fund.
