PROHIBITORY ORDER UNDER SECTION. 144 CR. P.C.

Whereas, it appears to me that there is every likelihood of breach of peace and tranquility in the district of Darrang as per the prevailing situation;

And whereas I am satisfied that there is need in the district of Darrang which warrants imposition of prohibitory order under Section 144 Cr.P.C;

Now, therefore I, Sri Dilip Kumar Borah, IAS, District Magistrate, Darrang, Mangaldai do hereby prohibit the followings to prevent any probable breach of peace and tranquility:

1. Any procession / demonstration / blockade on National Highway – 15.
2. Entry of unauthorized person or unnecessary crowding / Dharna around the premises of Deputy Commissioner and within 100 (one hundred) meters radius of the Deputy Commissioner's office.
3. Assembly of five or more persons in public places including National Highway without permission from the authority concerned.
4. Procession / Meeting / Protest meeting / Dharna / Rallies which may create communal tension.
5. Holding of public meeting, rally and demonstration in public place without permission from the competent authority.
6. Carrying and display of arms / Lathies / Lethal weapons / Sharp instruments / Bows and arrows/ Daggers / Daos / Swords / Trishuls etc. by any person or group of persons in public places.
7. Use of loud speakers without permission from the competent authority.
8. Gherao of any person, office premises, godown, etc.
9. Writing of posters in Govt. buildings, walls, roads etc. by any group of persons.
10. Plying of ferries/boats/steamers to and from the district from 6-00 PM to 7-00 AM and their overloading.
11. Wearing of combat clothes by civil population.

This ex-parte order will come into force throughout the District with immediate effect and will remain in force until further order.

Any person(s) violating the order will be prosecuted under section 188 of the Indian Penal Code.
