ORDER

Whereas, the Secondary Education Deptt., Govt. of Assam vide Notification No.ASE.01/2020/Pt.V/4 dated 27th April, 2021 has issued directives to close down all Educational Institutions (Govt. and Non-Govt.) from Pre-Primary section to University level along with Hostels and Coaching Institutions, for a period of 15(fifteen) days, as an when the cumulative total number of positive COVID cases during last 10(ten) days exceeds the 300 mark.

Whereas, the situation of COVID-19 in Darrang District has been reviewed and it has been observed that the cumulative total number of positive COVID cases during last 10(ten) days exceeds the 300 mark.

Considering the seriousness of the situation, to contain the spread of the COVID-19 virus, in pursuance of Govt. letter No.ASE.01/2020/Pt.V/4 dated 27th April,2021 and partial modification and in continuation of this office orders vide No. DDMA.11/2020/PT.I/391-392 dtd.20/04/2021,DDMA.11/2020/PT.I/401 dtd.23/04/2021 & DDMA.11/2020/PT.I/407 dtd.26/04/2021,in the exercise of the power conferred under Section 22(2) (h) of the Disaster Management Act 2005. I Shri Dilip Kumar Borah, IAS, Deputy Commissioner Darrang cum Chairman, District Disaster Management Authority, therefore, in my capacity as the Chairman of the District Disaster Management Authority do hereby issue order to close down all Educational Institutions (Govt. and Non-Govt.) from Pre-Primary section to University level along with Hostels and Coaching Institutions of this District, for a period of 15(fifteen) days.

It is further directed that the online mode of Education should be made available for these

students as a part of continuous learning process.

This order will come into force with immediate effect.
