O R D E R

In view of the significant increase of COVID-19 Positive Cases in Darrang District and in pursuance of Govt. Order vide No.ASDMA.24/2020/Pt.2/241 dated 12th May/2021, the following restrictions in regards to plying of Private/ Personal Vehicles have been made from 5.00 AM to 2.00 PM w.e.f.13th May/2021 in urban areas and adjacent areas within 5 Kms radius from the periphery of Municipal Boards / Revenue Towns under Darrang District until further order.

1. Vehicles with Odd Number will be allowed to ply on Odd Dates. (Example: Vehicle Number ending with 1/3/5/7/9 on 13th /15th /17th /19th /21st /23rd /25th May/2021 etc.)
2. Vehicles with Even Number will be allowed to ply on Even Dates. (Example: Vehicle Number ending with 0/2./4/6/8 on 14th /16th /18th /20th /22nd /24th /26th May/2021 etc.)

However, these restrictions will not be applicable in respect of Govt. Vehicles /Water Tankers/Milk Carrying Vehicles /Ambulances/ LPG Distribution Vans, Vehicle Hired/ Private used for Medical Duty/ COVID-19 Duty on production of valid ID Proof, and personal vehicles used for Medical Emergencies.

Moreover, this restriction will also not be applicable for the vehicles plying in National Highway .
