ORDER


Whereas a large number of COVID-19 positive cases have been detected in the District of Kamrup (Metro) leading to subsequent imposition of "Total Lockdown" in the district to contain the spread of COVID-19.

Whereas, it is felt necessary to impose restriction on back and forth journey of people from Kamrup(Metro) to Darrang district and vice versa in the interest of maintenance of public health, hygiene and safety of general public.

In view of the above, I, Shri Dilip Kumar Borah, IAS, Deputy Commissioner Darrang, therefore, in my capacity as the Chairman of the District Disaster Management Authority, in the exercise of the power conferred under section 34 of the Disaster Management Act 2005 do hereby impose restriction on back and forth journey of people from Kamrup (Metro) to Darrang District and vice versa under general circumstances in the interest of maintenance of public health, hygiene and safety of general public.

All heads of Departments, Darrang shall ensure that no back and forth journey of officials and staff of their Department to Kamrup (Metro) shall take place until further order. Any such unauthorized movement must be immediately brought to the notice of the undersigned for further necessary action from this end.

This order comes into force with immediate effect.


