The last date for submission of tender is 3.00 PM of 03 /03/2021 and the tenders will be opened on the same day at 4.00 PM, in the presence of the bidders or their authorized representative.

TERMS AND CONDITION


- (a) The bidders must attach the self attested copies of firm registration Certificate, GSTIN, PAN Number, Trade License from MB/TC etc. and **Current Bank Account** No. of with the tender.
- (b) GPS to be equipped with Real Time Map, MIS, map upload support and life time traffic alert facilities.
- (c) The successful bidder shall supply GPS Devices with SIM/Data cards for enabling GPRS on the GPS Device for Vehicle Tracking.
- (d) The bidders should always keep sufficient nos. of buffer stocks ready to replace the faulty devices without loss of time.
- (e) Bidders will have to ensure for supplying qualitative materials. If any supplier fails to supply qualitative materials, his/her order will be rejected immediately.
- (f) The rates should be inclusive of all taxes.
- (g) The bidders will have to deposit an amount of Rs. 10,000/- (Rupees Ten thousand) only as security deposit in the form of Demand draft/Call Deposit in favour of Deputy Commissioner, Darrang, Mangaldai payable at Mangaldai with the tender.
- (h) In case the bidders/successful bidder(s) are found in breach of any condition(s) of tender at any stage, legal action as per rules/laws shall be initiated against the agency concerned. In such case, Security money deposited shall be forfeited.
- (i) No advance payment will be made.
- (j) Payment will be made after election process is over and subject to availability of fund.


