Sealed tenders affixed with non-refundable court fee stamps of Rs. 8.25 (Rupees and eight and twenty-five paise) only are invited from registered firms / suppliers for **Webcasting of Poll Process** with installation of the Computer accessories as shown at Annexure-A in connection with forthcoming Assembly Election, 2021 :

The last date for submission of tender is 3.00 PM of 03 / 03 /2021 and the tenders will be opened on the same day at 4.00 PM, in the presence of the bidders or their authorized representative.

TERMS AND CONDITION

- (a) The bidders must attach the self attested copies of firm registration Certificate, GSTIN, PAN Number, Trade License from MB/TC etc. and **Current Bank Account** No. with the tender.
- (b) Bidders will have to ensure for supplying qualitative materials. If any supplier fails to supply qualitative materials, his/her order will be rejected immediately.
- (c) The rates should be inclusive of all taxes.
- (d) The bidders will have to deposit an amount of Rs. 10,000/- (Rupees Ten thousand) only as security deposit in the form of Demand draft/Call Deposit in favour of Deputy Commissioner, Darrang, Mangaldai payable at Mangaldai with the tender.
- (e) In case the bidders/successful bidder(s) are found in breach of any condition(s) of tender at any stage, legal action as per rules/laws shall be initiated against the agency concerned. In such case, Security money deposited shall be forfeited.
- (f) No advance payment will be made.
- (g) Installation process for Webcasting must be completed at the selected polling stations prior to two days of Poll for Assembly Election, 2021.
- (h) Payment will be made after election process is over and subject to availability of fund.
- (i) Deputy Commissioner, Darrang has the right to accept or reject any or all tenders without assigning any reason thereof and has the right to fix the price of any materials as per prevailing market rate.


