3. Two copy of passport size photographs , Caste Certificate, Voter id, Pan Card, Baki Jai Clearence Certificate, Uptdate Receipt of land revenue from the relevant authority must be enclosed alongwith the tender
4. Only the water area will be given on lease & not the land area.
5. The successful bidder will not be allowed to dig out or renovate the tank.
6. The successful bidder will have to deposit 25% of one year lease value at the time of agreement as security money.
7. The lease amount of each year must be paid in 2 (Two) instalment. First installment (50% of lease value) and 2<sup>nd</sup> instalment (50% of lease value) at the time interval of 6 (Six) months fixed by the undersigned.
